

2024 INCOME DISCLOSURE STATEMENT

The average monthly income for Active Associates was \$91.57 during the 2024 calendar year. An "Active" Associate is an Associate who earned a commission or made at least one purchase. Fifty Six percent of Active Associates did not earn a commission in 2024. The chart below contains income information for all Active Associates based on Rank. Because an Associates' Rank can vary over the course of a year, the chart averages are based on the paid rank of Associates in each month.
